Dear participants of the First Russian-American Child Welfare Forum,

It is a special honor for the Republic of Buryatia to host the Forum, in the year of the 350th anniversary since it became part of Russia. It is important that participants from different regions of Russia and the United States of America gathered together to discuss child protection-related issues, share their experience and find the most efficient ways to tackle childhood problems.

The Government of Buryatia and the National Foundation for the Prevention of Cruelty to Children implement a joint program aimed to reorganize the obsolete child protection system. In current situation, the main tasks of child and family welfare institutions are early prevention of family problems and social abandonment prevention. We are establishing a new system of preventive services for families and also developing child adoption and foster care services for the abandoned and/or neglected children and the children without parental care.

Thanks to a massive preventive effort, in the past three years 1,370 children were granted the right to live with natural relatives. In this period in Buryatia 352 children were adopted; 4,300 children currently remain under guardianship. The number of foster families grows annually by 100, and currently amounts to 540. 842 children are raised in foster families. Our aim is to provide every child in Buryatia with a loving and caring family.

The mission of the Government of Buryatia for 2012-2014 is to provide orphans with decent accommodation using both budget and loan funds.

The Government of the Russian Federation praised our child protection efforts.

I believe that the professionalism and commitment of the participants of this Forum will help us discuss and develop important solutions for the sake of our children.

Let this be a fruitful event!

ABOUT THE FORUM

On August 1-6, 2011, the first Russian-American Child Welfare Forum (RAF) will be held on Lake Baikal in the Republic of Buryatia, Russian Federation. The Forum was initiated by Russian specialists working as part of the Child Protection Subgroup under the Civil Society Working Group of the Bilateral Presidential Commission (Obama-Medvedev) established in October 2010.

The event is supported by the RF Presidential Executive Office and the Presidential Plenipotentiary Envoy in the Siberian Federal District.

GOAL AND TASKS OF THE FORUM

The goal

The goal is to boost the development of Russian-American dialogue and partnership in resolving pressing national and international child protection-related issues.

Tasks of the Forum include:

- Facilitating large-scale interdisciplinary discussion among American and Russian child protection and child welfare specialists with the goal of strengthening professional relationships, alliances and contacts between the groups
- Presenting best Russian and American practices in the prevention of child abuse and violence against children
- Comparative analysis and coordination of values and conceptual approaches to aid future joint action in the field of child protection
- Discussion on civil society participation in protecting children's rights

The agenda of the Forum was drawn up by the leading Russian and American experts on child protection. The issues for discussion are relevant for both countries. The agenda includes theoretical and practical child protection-related issues.

The Organizing Committee aimed to make the discussions on the Forum as practical as possible. On August 1, prior to the official opening, the participants will have an opportunity to see how the system of early detection of child abuse works and get acquainted with how the interdisciplinary teams tackle these cases in the Republic of Buryatia. The agenda includes visits to different governmental and administrative bodies, meetings with town and rural experts, municipal administrators and representatives of the Agency for Child and Family Issues of the Republic of Buryatia.

On **August 2**, those eager will have an opportunity to visit the organizations providing innovative preventive services for children and families. Several venues will exhibit 12 different preventive services for children and

families at risk. The participants will see the examples of effective prevention of social abandonment in medical, educational, social welfare institutions, the Agency for Child and Family Issues. We believe that in these two days the participants will get the general idea of innovative efforts aimed at social abandonment and child abuse prevention in the Republic of Buryatia and see the new child protection methods and technologies for further discussion during the Forum.

The agenda includes three plenary sessions focused on fundamental issues of child protection effectiveness with the lectures by leading experts from Russia and the United States. 13 discussion platforms will be dedicated to plenary and workshop reports and lectures. The agenda includes over 10 Russian and American workshops and presentations on effective approach to practical child protection-related issues that will show 'live' the work of acclaimed Russian and American experts. The Forum also offers free discussions focused on the issues of special interest for the participants.

Thanks to the participation of government officials and experts working in child protection system, it will be possible to discuss the most relevant aspects of Russian and American child protection experience on a professional, interdisciplinary and intersectoral level.

In order to facilitate a professional and detailed discussion of the most relevant issues, every day of the Forum has its own theme.

On **August 3**, the third day of the Forum, the participants will discuss the issues of child abuse prevention. The agenda includes discussions on theoretical and practical issues of child abuse protection. The experts believe that it is crucial to comprehend the nature of this social phenomenon. The plenary session will be focused on historical, cultural and psychological analysis of violence against children. The professional discussion will not only reveal the ways of development of this phenomenon but will also help plan targeted prevention programs, which is especially important now that both in Russia and the USA the civil society's attention is drawn to child abuse prevention but the resources for such efforts remain limited.

The participants will have an opportunity to discuss a wide range of issues: early child abuse prevention, children rights protection culture development, the role of the state and the civil society in child protection, national and regional peculiarities. The most interesting technologies and experience will be presented by the Russian and American experts at the Presentation Fair.

On August 4, the participants will discuss the emergency assistance and the rehabilitation of victims of child abuse and their families. The discussion platforms will focus on the efficiency of child assistance as well as on the issues of foster care and adoption of abandoned children and the children without parental care. The participants will also discuss training methods for staff working with children. Apart from that, the experts will discuss training and methodological support, these being the two issues especially important for effective child protection. In the afternoon the best Russian and American practices in the rehabilitation of children victims of violence will be presented in a series of workshops and Russian and American participants will have an opportunity to see and discuss Russian and foreign approach to different professional challenges. The participants will also be offered films and documentaries on best practices in the rehabilitation of children victims of violence.

It is important that the Russian and American experts have an opportunity to share their experience at the highest level and see their colleagues' approach. That is why experience exchange is one of the main tasks of this Forum.

On August 5, the participants will discuss national and international problems in child welfare that require international cooperation: child pornography and prostitution, child trafficking, pedophilia. These issues require joint efforts and political decisions. Representatives of the United States Department of Justice, Children Rights Commissioner's for the President of the Russian Federation, regional Child Ombudsmen will share their experience.

The specialists and decision-makers from child protection services responsible for the development of regional systems of child abuse prevention will discuss the most effective national child protection strategies, develop joint approach to the pressing issues and coordinate their plan of actions as well as find allies and associates.

The agenda of August 6, includes a plenary session dedicated to the results of the Forum, its Resolution and Russian-American cooperation planning in child protection efforts.

The Forum will also include several events within the framework of international projects and programs implemented by NFPCC.

'A COMPASS FOR CHILDHOOD' PROGRAM

The main goal of 'A Compass for Childhood' Program (2010-2014) is expert and methodological support for the development of services for children and families at-risk. It includes: study and promotion of the best practices of social abandonment prevention and foster care and/or adoption of children without parental care; developing a Toolkit for Regional Planning, implementation and evaluation of regional programs; establishment of Centers of Excellence for the advanced training of the staff working with children.

The Forum includes a roundtable 'Components of an Effective Child Welfare System (Standards, Infrastructure and Financing)' and the presentation of the Center of Excellence established under the 'A Compass for Childhood' Program in the Republic of Buryatia.

'PROTECTED CHILDHOOD' PROJECT





The aim of the 'Protected Childhood' Project is to create conditions for detailed analysis and study of major problems of child protection system development and to find the ways to tackle these problems; develop coordinated approach to current issues of social policy in child protection during the open discussions with governmental bodies' representatives and the professional community. The Project is implemented jointly by the National Foundation for the Prevention of Cruelty to Children and the International Foundation for Socio-Economic and Political Studies (The Gorbachev Foundation) and includes a series of roundtable and the development of a website to promote wide discussion of child protection issues.

Under the 'Protected Childhood' Project the Forum will host an interregional meeting 'Governmental Social Policies and Demographics of Child Protection' and the 'Protected Childhood: Threats of Contemporary World and Counteractions' roundtable.

Given the level of the Forum, the organizers believe that all the decisions and recommendations drawn up by the participants will give an impetus to child protection development in both countries.

ABOUT THE CHILD PROTECTION SUBGROUP UNDER THE CIVIL SOCIETY WORKING GROUP OF THE BILATERAL PRESIDENTIAL COMMISSION (OBAMA-MEDVEDEV)

The Bilateral Russian-American Presidential Commission (Obama-Medvedev) was established in 2009. Its activities are coordinated by the Russian Foreign Minister Sergey Lavrov and the US State Secretary Hillary Clinton. The Commission consists of 16 working groups including the Civil Society Working Group supervised by the First Deputy Chief of Staff of the RF Presidential Executive Office, Vladislav Surkov, and the Special Assistant to the President within the US Security Council, Michael McFaul.

The Child Protection Subgroup is headed by the Children Rights Commissioner for the President of the Russian Federation, Pavel Astakhov, and the chief of Child Exploitation and Obscenity Section of the United States Department of Justice, Andrew G. Oosterbaan.

The first session of the Civil Society Working Group was held on January 27, 2010 in Washington and attended by the representatives of Russian and American governmental bodies and NGOs. The session was focused on anticorruption efforts and child protection against different forms of violence and exploitation.

In June, 2010, during Obama-Medvedev Summit, the U.S.-Russian Civil Society Summit took place. Within the framework of the Summit the experts on child protection held a meeting dedicated to the cooperation of the two countries in child protection-related issues.

On October 6, 2010 Russian and American members of the Child Protection Subgroup held respective meetings in their countries to discuss possible joint bilateral projects on child protection. In Russia the meeting was supported by the International Research and Exchanges Board (IREX) and hosted by the National Foundation for the Prevention of Cruelty to Children and the International Foundation for Socio-Economic and Political Studies (The Gorbachev Foundation). Over 30 experts and managers from 15 regions of Russia formed a package of project offers including the Russian-American Child Welfare Forum on Lake Baikal, regular on-line consultations, case studies, and joint scientific research.

On December 24, 2010 Pavel Astakhov, Children Rights Commissioner for the President of the Russian Federation, held a meeting with NGOs representatives to draw up the proposals of further cooperation between Russian and American NGOs, foundations and non-profit organizations.

On February 16, 2011 another meeting of the subgroup took place in Moscow. The participants discussed the issues of the fight against child pornography and child abuse in the Internet, establishment of a Help Center for Missing Children and Children Victims of Violence and Abuse in Russia.

Another meeting of the Subgroup, held on June 7, 2011 in Washington, was focused on the role of the civil society in fight against child exploitation and pornography. The participants decided to study the ways for expanding the activities of the Subgroup and discuss a wider range of child protection-related issues. Marina Egorova, President of the National Foundation for the Prevention of Cruelty to Children, informed the participants of the forthcoming First Russian-American Child Welfare Forum on Lake Baikal.








FORUM ORGANIZERS AND PARTNERS

CHILDREN RIGHTS COMMISSIONER FOR THE PRESIDENT OF THE RUSSIAN FEDERATION



One of the main objectives of the Children Rights Commissioner for the President of the Russian Federation is to guarantee child protection and restore violated rights of children.

Thus, the Children Rights Commissioner is granted a number of rights including the right to request and receive data and materials from governmental bodies, visit the headquarters of federal administrative bodies, audit (by himself or jointly with the authorized bodies) the work of executive authorities and officials, submit recommendations regarding possible and necessary actions to restore violated rights and interests of the child to the federal executive bodies.

The Children Rights Commissioner for the President of the Russian Federation supports the activities of the Association of Ombudsmen for Children in the regions of the Russian Federation.

In December, 2009, the President of Russia, Dmitry Medvedev, appointed Pavel Astakhov as the Children Rights Commissioner for the President of the Russian Federation.



FORUM VENUES

The events of the First Russian-American Child Welfare Forum will take place in the capital of Buryatia, Ulan-Ude, and on Lake Baikal (Kabansky District).

Main venue: building of the Government of the Republic of Buryatia (Ulan-Ude).

Main venue on Lake Baikal: school in the Sukhaya village built under the 'Education' National Priority Project. Discussion platforms will be held in guest houses' conference rooms.

LAKE BAIKAL, THE 'SACRED SEA'

Lake Baikal is one of the world's greatest natural wonders, and is unique in the world for its pristine beauty. In 1996, it was designated as a UNESCO world heritage site. Located in Siberia, between the region of Irkutsk and the Republic of Buryatia, it has the distinction of being not only the oldest lake in the world (at an estimated 25-30 million years old) but also the deepest, at a depth of nearly 1.7 miles. The lake is a truly stunning ecological study: it holds nearly twenty percent of the world's fresh water, which also happens to be one of the purest water sources in the world. Baikal has special self-cleaning microorganisms responsible for keeping the lake clean, and its ecological environment have remained largely untouched by pollution. Visitors are remarkably surprised at the clarity of the water, which allows one to see far into its depths on a sunny day.

Baikal contains over 2,000 species of flora and fauna, two-thirds of which are unique to the lake. Its natural attractions and beauty include: spanning breathtaking mountains, hot springs, pebbled beaches and islands. The lake is home to the Baikal seal, one of the few freshwater seal species in the world, as well as the whitefish omul, a specialty and favorite of the locals, often for sale in its smoked form at rest stops along the lake. It is fed by more than 300 rivers and tributaries, and drained through only one river, the Angara.

Baikal's most famous landmark is the Shaman's Rock on the island of Olkhon (Baikal's largest island and one of the third largest lake-bound islands in the world). Indeed, a strong shamanist tradition still holds strong along the western shore of the lake. Olkhon is considered to be a center of particular power. Shamanistic beliefs found in the Republic of Buryatia around Baikal are indivisible from the land itself: In the shamanistic tradition, gods and spirits are associated with different natural landmarks and areas, and it is still possible to meet with local shamans. While traveling, it is not unusual to stop and make an offering to various gods or spirits for safe passage through that area. For locals, even those without a specific religious orientation, Baikal remains a sacred place, one that they take fierce pride in and refer to as 'the Sacred Sea.'
